**STUDIO POLICIES & PARENT INFORMATION**

**Please read and initial that you understand and agree to the following policies:**

- \_\_\_\_\_ Non-refundable registration fee of \$30 per student/\$15 for each additional sibling per year.
- \_\_\_\_\_ Full tuition is required every month including the month of June.
- \_\_\_\_\_ Tuition and fees are non-refundable.
- \_\_\_\_\_ Forever Dance fees are based on a cash program. If paying by debit or credit card, a 4% fee will be assessed.
- \_\_\_\_\_ Accounts are considered past due on the 6<sup>th</sup> of the month. Your account will **automatically** be charged a late fee of \$25, plus 10% of the overdue balance on the 7<sup>th</sup> of each month.
- \_\_\_\_\_ Payment can be made directly through Quickbooks using the e-check option. We accept personal checks. A fee of \$35 will be assessed for all returned checks and echecks. Forever Dance will no longer accept a personal check after an account that has had a insufficient fund/returned check.
- \_\_\_\_\_ Autopay Option- If you wish to sign up for Autopay, please fill out the Autopay form with your credit card information to avoid paying late fees. Your monthly tuition will be charged **automatically** on the first of every month. 4% fee will apply.
- \_\_\_\_\_ You will receive your monthly tuition invoice 7 days prior to the due date. The front desk must be notified by an email to [foreverdancelt@gmail.com](mailto:foreverdancelt@gmail.com) before the 1<sup>st</sup> of the month if the student is withdrawing from a class or you will be responsible for the full tuition of the withdrawn class.
- \_\_\_\_\_ Dance classes are not pro-rated for missed classes. A missed class may be made up within 30 days. Only 2 make-ups per class are allowed each month. Make-ups must be in classes other than the class missed and must be the correct level for dancer. Dancer cannot take a make-up in a class that is full. Make-ups must not substitute for tuition and can only be made up if dancer's tuition has been paid.
- \_\_\_\_\_ Aerials silks classes are not pro-rated for missed classes. There are no make-ups for missed aerial silks classes.
- \_\_\_\_\_ Drop-Ins: Students may take classes at drop-in rate providing that there is room in the class and that the class is not preparing for the recital. All drop-in students are required to pay either the annual \$30 annual registration fee, or pay a \$5 daily registration fee in addition to the class drop-in rate.
- \_\_\_\_\_ All accounts must be paid in full for dancer to perform in the Recital.
- \_\_\_\_\_ All dancers participating in Recital 2021 will be billed a Recital package fee (due 02/15/21) of \$75 for the first child, and \$50 for each additional sibling. Each child will receive two recital tickets and one recital t-shirt. Each family will receive a link to the digital video download of the recital. The digital download will be available once the edit is complete. A DVD of the recital will be available for an additional fee of \$15 for families who have paid recital fee.
- \_\_\_\_\_ Forever Dance does not allow children to be at the studio unless they have classes on that day.
- \_\_\_\_\_ At FDLT-Forever Dance Lake Tahoe the drive through is for pick-ups/drop offs only – no waiting allowed. When picking up dancers, wait in parking areas until dancers are in the doorway before pulling into drive through.
- \_\_\_\_\_ I acknowledge and consent to allow Forever Dance to use: photos and/or videos of my child/myself in publications, advertisements, our studio's website, or on social media sites. I understand that in some cases, my child and/or my name may be used. I further understand no financial compensation will be for use of these photos/videos.

## **PARTICIPANT WAIVER**

The undersigned participant and participant's parent or legal guardian represent that they are fully aware and apprised that there are risks and physical demands incident to the physical activities involved in dance, aerial silks, tumbling, dance competition and dance/tumbling, and that these classes contain dangers and inherent risks that can result in serious bodily injury or death that no amount of care, caution, instruction, or expertise can eliminate. I understand the scope, nature and extent of the risks involved and voluntarily and freely choose to assume any and all such risks. I fully understand that these activities involve risks of serious bodily injury, including permanent disability, paralysis, and/or death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my participation in the activity. Participant and Guardian further represent, having full knowledge of Participant's limitations that participant is physically fit and has sufficiently trained for participation in dance, aerial silks, tumbling, dance competition and dance/tumbling. Participant and Guardian or representatives hereby release, indemnify and hold harmless Forever Dance and each of their affiliates, officers, and agents for any and all claims, demands, losses, actions, liability, costs, damages and expenses (including attorneys fees and other costs of litigation), known or unknown, arising from or incident to any injury, loss of occurrence or omission related in any way to dance, aerial silks, tumbling, dance competition and dance/tumbling or the operation of Forever Dance. Participant agrees to adhere to safety precautions dictated by the instructor and Forever Dance. Participant and/or Guardian or representatives hereby release, indemnify and hold harmless Forever Dance and each of their instructors, affiliates, officers, and agents for any and all claims, demands, losses, actions, liability, costs, damages and expenses (including attorneys fees and other costs of litigation), known or unknown, arising from or incident to any injury, loss of occurrence or omission related in any way to dance, aerial silks, tumbling, dance competition and dance/tumbling or the operation of Forever Dance. Participant and Guardian acknowledge that Forever Dance Does Not provide insurance for injuries suffered in connection with dance, aerial silks, tumbling, dance competition and dance/tumbling and that it is the responsibility of participant and guardian to obtain adequate insurance coverage to cover the participant's risk of injury.

\_\_\_\_\_ I give my permission for my child/children to be transported by ambulance, aid car, or staff car to an emergency center for treatment in the case that a parent or guardian cannot be reached.

**Acknowledgment of Understanding:** The undersigned have read this ASSUMPTION OF RISK, RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and have had the opportunity to ask questions about the same. \* Neither my child(ren) nor I am experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.

\* My child(ren) and I have not traveled internationally within the last 14 days.

\* My child(ren) and I have not traveled to a highly impacted area within the United States of America in the last 14 days.

\* I do not believe my child(ren) nor I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.

\* My child(ren) and I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non contagious by state or local public health authorities.

\* My child(ren) and I are following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I hereby release and agree to hold Forever Dance harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to my child(ren) and/or I and/or property that may be caused by any act, or failure to act of Forever Dance, or that may otherwise arise in any way in connection with any services received from Forever Dance.
