STUDIO POLICIES & PARENT INFORMATION

Please read and initial that you understand and agree to the following policies:

_____ Non-refundable registration fee of \$35 per student/\$20 for each additional sibling per year.

_____ Full tuition is required every month including the month of June.

_____ Tuition and fees are non-refundable.

_____ Forever Dance fees are based on a cash program. If paying by debit or credit card, a 4% fee will be assessed.

_____ Accounts are considered past due on the 6th of the month. Your account will **automatically** be charged a late fee of \$25 on the 7th of each month. An additional late fee of 10% of the total overdue balance will be added on the 1st of each month.

_____ Payments can be made directly through Quickbooks using the e-check option. We also accept personal checks and cash. A fee of \$35 will be assessed for all returned checks and e-checks. Forever Dance will no longer accept a personal check after an account that has had an insufficient fund/returned check. A 4% fee will be assessed if paying by credit or debit card.

_____ Autopay Option- If you wish to sign up for Autopay, fill out the Autopay form in person with your credit card information to avoid paying late fees. Your monthly tuition will be charged **automatically** on the first of every month. 4% fee will apply.

_____ You will receive your monthly tuition invoice 7 days prior to the due date. The front desk must be notified by an email to foreverdancelt@gmail.com before the 1st of the month if the student is withdrawing from a class or you will be responsible for the full tuition of the withdrawn class.

_____ A 10% discount is available if you pay for the entire 2025-26 season (September – June) by September 15, 2025. This payment must be made by September 15th. **This is non-refundable with no exceptions.**

_____ Dance classes are not pro-rated for missed classes. A missed class may be made up within 30 days. Make-ups must be the correct level for dancer. Dancer cannot take a make-up in a class that is full. Make-ups must not substitute for tuition and can only be made up if dancer's tuition has been paid.

_____ Drop-Ins: Students may take classes at drop-in rate providing that there is room in the class and that the class is not preparing for the recital. All drop-in students are required to pay either the annual \$35 annual registration fee, or pay a \$5 daily registration fee in addition to the class drop-in rate.

_____ All accounts must be paid in full for a dancer to perform in the Recital, including private lesson fees.

_____ All dancers participating in Recital 2026 will be billed a Recital package fee (due 02/15/26) of \$85 for the first child, and \$60 for each additional sibling. Families will receive two recital tickets and one recital t-shirt for per dancer. Each family will receive a link to the digital video download of the recital. The digital download will be available once the edit is complete.

_____ Recital costume deposit total amount for each dancer will be divided into two equal payments. The first payment will be due 3/1/2026. The second payment will be due 4/1/2026.

_____ Forever Dance does not allow unattended children to be at the studio unless they have classes on that day.

_____ At FDLT-Forever Dance Lake Tahoe the drive through is for pick-ups/drop offs only – no waiting allowed.

_____ At FDCC-Forever Dance Carson City dancers should wait inside the outer lobby when waiting to be picked up.

_____ I acknowledge and consent to allow Forever Dance to use: photos and/or videos of my child/myself in publications, advertisements, our studio's website, or on social media sites. I understand that in some cases, my child and/or my name may be used. I further understand no financial compensation will be for use of these photos/videos.

PARTICIPANT WAIVER

The undersigned participant and participant's parent or legal guardian represent that they are fully aware and apprised that there are risks and physical demands incident to the physical activities involved in dance, tumbling, dance competition and dance/tumbling, and that these classes contain dangers and inherent risks that can result in serious bodily injury or death that no amount of care, caution, instruction, or expertise can eliminate. I understand the scope, nature and extent of the risks involved and voluntarily and freely choose to assume any and all such risks. I fully understand that these activities involve risks of serious bodily injury, including permanent disability, paralysis, and/or death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my participation in the activity. Participant and Guardian further represent, having full knowledge of Participant's limitations that participant is physically fit and has sufficiently trained for participation in dance, tumbling, dance competition and dance/tumbling. Participant and Guardian or representatives hereby release, indemnify and hold harmless Forever Dance and each of their affiliates, officers, and agents for any and all claims, demands, losses, actions, liability, costs, damages and expenses (including attorney's fees and other costs of litigation), known or unknown, arising from or incident to any injury, loss of occurrence or omission related in any way to dance, tumbling, dance competition and dance/tumbling or the operation of Forever Dance. Participant agrees to adhere to safety precautions dictated by the instructor and Forever Dance. Participant and/or Guardian or representatives hereby release, indemnify and hold harmless Forever Dance and each of their instructors, affiliates, officers, and agents for any and all claims, demands, losses, actions, liability, costs, damages and expenses (including attorney's fees and other costs of litigation), known or unknown, arising from or incident to any injury, loss of occurrence or omission related in any way to dance, tumbling, dance competition and dance/tumbling or the operation of Forever Dance. Participant and Guardian acknowledge that Forever Dance Does Not provide insurance for injuries suffered in connection with dance, tumbling, dance competition and dance/tumbling and that it is the responsibility of participant and guardian to obtain adequate insurance coverage to cover the participant's risk of injury.

_____ I give my permission for my child/children to be transported by ambulance, aid car, or staff car to an emergency center for treatment in the case that a parent or guardian cannot be reached.

Acknowledgment of Understanding: The undersigned have read this ASSUMPTION OF RISK, RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and have had the opportunity to ask questions about the same. The undersigned fully understand this assumption of risk, release and waiver of liability and indemnity agreement, and that the undersigned are giving up substantial rights in connection therewith, and that its terms are contractual, and not a mere recital. I acknowledge that I have been advised to obtain independent legal advice concerning the ramifications of signing this document. The undersigned acknowledge that they are signing this agreement freely and voluntarily.
